CALL US

Emergency Calls Only: 888-983-4616

This means you are currently being threatened, intimidated, or harassed by any public servant, police, sheriff, or business owner or patrons.

P.A.T.

Call your local Patriot Action Team (find info about P.A.T. on our website).

RECORD

Take videos and photos! Document everything that is going on.
Record all conversations with your smartphone.

QUESTION

Ask them the following question:

*"By what authority do you have to trespass on my rights
without due process of law?"*

USC 4th, 6th, Amendments, Title 18 section 242 Deprivation of Rights under Color of Law,
Title 18 section 241, Conspiracy against Rights. / Marbury v. Madison (1803):

*"Anything repugnant to the Constitution is no law, has no force of law
and can be ignored."* Simply ignore it.

THEY WILL BE SUED

State the following: "Are you aware that Constitutional Law Group will sue you in your official and private capacity, if you proceed to violate my rights? You will lose everything you own, your homes, cars, everything you have worked for.

Are you also aware that we have the right to go after any public servants indemnity bond?"

SIGN

If you are forced to sign ANY UNLAWFUL papers, sign your name with the words "Under Duress" after it, and draw a rectangle around it so your signature is enclosed.

UCC1-308: Performance or Acceptance Under Reservation of Rights.

'A party that with explicit reservation of rights performs or promises performance or assents to performance in a manner demanded or offered by the other party does not thereby prejudice the rights reserved. Such words as "without prejudice," "under protest," or the like are sufficient.'

SHERIFF

If they call the police, YOU CALL THE SHERIFF. The Sheriff is the highest authority in the County. It is his duty to protect you from intrusive government.

Supreme court rulings:

Hoffsomer v. Hayes, 92 Okla 32, 227 F. 417

'The courts are not bound by an officers interpretation of the law under which he presumes to act.'

Sramek v. Sramek, 17 Kan. App 2d 573, 576-7,

840 P. 2d 553 (1992), rev. denied 252 Kan. 1093 (1993)

'The law provides that once State and Federal jurisdiction has been challenged, it must be proven.'
